RMLEFCU lands national Top Ten status again in 2018.

Last month, RMLEFCU received notification that, once again, we have placed in the Top 10 of 5,743 American credit unions.

"I wanted to reach out and congratulate you for being named to the 2018 DepositAccounts Top200 list of Healthiest Credit Unions in the United States," began the letter from Christopher Trum, Senior Manager at Deposit Accounts, who added that our ranking landed us in the national Top 10. "RMLEFCU achieved an incredible 'A+' health rating in the 2018 DepositAccounts financial health study."

According to Trum, the citation is "an outstanding distinction and vote of confidence for how well Rocky Mountain Law Enforcement Federal Credit Union is being managed and run." The ranking is based on such scales as capitalization, deposit growth, and the Texas Ratio – which is figured on the amount of at-risk loans carried by the credit union.

Our President and CEO Christine Wiley points out that this is the fourth straight year of Top 10 status for RMLEFCU, a signpost of strength and stability that puts our credit union at the top of its field. No extra measures are undertaken to achieve this ranking; it's simply the way we work.
